- Provide daily support to team members.
- The administrative role will involve helping the Research Director complete research studies, compile and collect data for program evaluation, including the LEAP Program and fieldwork assessment, and help choose and acquire equipment for data collection and analysis. Other administrative duties may include copying and/or scanning articles and chapters, typing and compiling reports, completing literature searches, coordinating and participating in conference submissions and presentations (i.e., there is potential to enhance one’s CV with a presentation or even publication), and all other duties as needed by the Chair, the Research Director, and the program. This may take place remotely for our online program or during travel for research purposes, or on-campus for on-site work. One potential opportunity is to be able to attend and/or present at the NU Performance Psychology Conference with expenses covered for the trip.
